Roll Call – Mayor and Council Members: Mayor Byron Anderson. Council Members Tom Tripp, Brent Marshall, Todd Castagno, and Mike Johnson. Councilman Paul Rupp was excused.

Councilman Tripp made a motion to approve the consideration of all of the agenda items on the agenda for this special meeting in addition to the canvass of the election results. Councilman Johnson seconded the motion. All voted in favor and the motion carried.

1. Summary Action Items

Councilman Tripp stated he would like to receive more information on the Rodney Myer business license. He stated it does not have a description of the business.

Motion: Councilman Marshall made a motion to approve the summary action items with the exception of the business license for Rodney Myer in order to receive more information. Councilman Johnson seconded the motion. All voted in favor and the motion carried.

3. Claim of EJL Homes, LLC (closed session)

Motion: Councilman Castagno made a motion to go into a closed session to discuss pending litigation and to invite James Vera and Erik Stromberg to attend the closed session. Councilman Johnson seconded the motion. All voted in favor and the motion carried.
